- Stewardship Ontario's We Recycle Portal is a web-based, user-friendly reporting tool to facilitate claim submission reporting
- Same content in a structured format
- Data is linked into our main system
- Accessible from any computer with internet accessibility
- Improved visibility and transparency
- Immediate acknowledgement/email notifications





Depot Hours – July1st 2013



- Applies to Depot Hours only
 - Total Reimbursable hours based on terms in the Municipal Amendment Agreement
 - Will receive one purchase order per year
 - 2013 will be issued a purchase order for July Dec 2013 Depot hours
 - Monthly payments
 - 2014 Purchase Order will be issued annually (at the start of the year calendar year)
 - Stewardship Ontario does not require:
 - monthly claim submission for depot hours
 - · supporting documentation for depot hours
 - Invoices for depot hours

Collection Site or event Date is missing



- Only Events & Post Collection Transportation of co-mingled materials services will be reported using SO's We Recycle portal
 - A 'system' contract is used to report each of these activities
- Improved visibility, tracking and communication for Muni's and SO
- Should there be any requests for missing information or updates required (i.e. collection site; contact names), Please forward requests to <u>mhswclaims@stewardshipontario.ca</u>

Events – July1st 2013



- Applies to Events only
 - Must advise SO of your events schedule ahead of time to ensure dates are entered into the system before reporting
 - If not, claim submission will be returned to be re uploaded with corrected information

What is Electronic Funds Transfer (EFT)?



- It is the electronic exchange, transfer of money from one account to another, either within a single <u>financial institution</u> or across multiple institutions, through <u>computer</u>-based systems.
- Deposited directly into bank accounts typically within 24-48 hours (faster than regular mail)
- Time and work effort savings





Reporting Changes

- When reporting any activities up to June 30th, 2013, your process remains the same
- When reporting any activities from July 1^{st,} 2013 onwards, submit your claim using We Recycle Portal
- By October 1st 2013, all claims are submitted to Stewardship Ontario using the We Recycle Portal

Next Steps...continued



- You will be receiving an email by July 30th
 2013 that will include the following information:
 - New Microsoft Excel Upload Spreadsheet
 - contains a 'system contract' number
 - sample data to facilitate correct reporting of your materials
 - User Id and a temporary password will be provided
 - First time you log into the Portal, you will be prompted to create your own password
 - Passwords: Only Stewardship Ontario can reset a password
